

CALL FOR RESEARCH ABSTRACTS 2017

The Canadian Society of Internal Medicine (CSIM) and invites you to submit abstracts to the **Postgraduate Oral and Poster Research Session** to be held during the CSIM Annual Meeting November 1-4, 2017 at the Hyatt Regency Toronto.

This competition is only open to **CSIM Resident Associates (PGY1 to PGY5 at the time of submission)**, in good standing, enrolled in a postgraduate residency training program in Internal Medicine or General Internal Medicine in Canada and to **CSIM Student Associates**, in good standing, enrolled in a faculty of medicine in Canada. If you are not already a CSIM Associate, you must complete [your application to join the CSIM](#) BY May 25, 2017 (delays in submitting a membership application will cause abstracts to be rejected by the system).

The CSIM encourages eligible research fellows, clinical associates and PGY6s and above to submit their work to the GIM Faculty Research Showcase. Learn more at: <http://csim.ca/awards-abstracts/>

1. Abstracts must present a clear, concise summary of the work. Do not include introductions, historical data, literature reviews, bibliographies or mention corporate support. Organize the body of the abstract to include:
 - a) Objective (preferably one sentence)
 - b) Methods used
 - c) Results
 - d) Conclusion.NOTE: Case reports are not accepted for the research session but can be submitted to the Ted Giles Clinical Vignettes session (see www.csim.ca for details).
2. Only one person may present. The person submitting the abstract MUST also be the presenter and is to complete the [abstract submission form](#). Only one abstract per project may be submitted. No images or graphs may be used. Abstracts should be no more than 350 words and must be submitted in English. In the title/body of your abstract, do not refer to patient names, city, province, hospital etc.
3. Only the name of the actual presenter will be included in the final meeting program and, for winners, announced through the CSIM website, newsletter, social media and journal. All correspondence regarding the submission will only be sent to the submitter.
4. Individuals may submit up to two abstracts across all three CSIM abstract competitions; however, only one oral may be presented (including QI and Ted Giles orals) and only one poster may be presented (including QI and Ted Giles posters). The way the abstract is submitted is how it will be reviewed. Grammar, spelling, etc. will not be checked. The review committee will determine whether an abstract is presented as a poster or as an oral presentation. Once an abstract is submitted, revisions to the text cannot be made.
5. Medical students submitting must provide a letter from the student's supervisor confirming the presenter is a trainee and at what level. This letter can be e-mailed directly to info@csim.ca.
6. Presenters must register for the CSIM meeting for at least the date of their presentation; posted rates applicable. The CSIM does not assume any costs of attending this meeting. The oral presentations and judged poster session is tentatively scheduled for Thursday, November 2, 2017; program subject to change.
7. Abstracts submitted to or presented at other national and international meetings may be submitted. Abstracts are not eligible for submission if the work has been published as a full paper in a peer-reviewed journal prior to the submission deadline of June 6, 2017. Abstracts are encouraged in a broad range of fields, including (but not limited to) Clinical Research, Health Services Research, Medical Education. 8. Trainees will be eligible for the **CSIM Awards for Postgraduate Research**. In recognition of the importance of the training of internists to the future of academic medicine in Canada, these awards acknowledge the best three oral and best three poster research presentations by trainees. The first place **oral** winner will be awarded a \$300 cash prize; \$200 for second place and \$100 for third place. The first place **poster** winner will be awarded a \$150 cash prize; \$100 for second place and \$50 for third place.
