CSIM SENIOR INVESTIGATOR AWARD 2024 Terms of Reference

The Senior Investigator Award is offered by the Canadian Society of Internal Medicine in recognition of excellence in the field of General Internal Medicine (GIM) research by a senior investigator.

ELIGIBILITY

- Is a Full Member of the Canadian Society of Internal Medicine (in good standing, dues paid).
- Is certified by the Royal College of Physicians and Surgeons of Canada and licensed to practice in Canada.
- Has achieved international recognition for research accomplishments.
- Has completed a 5-year GIM specialty training pathway or completed 4 years of training and works primarily in GIM (e.g. their primary clinical appointment is in GIM).
- Has held full-time faculty appointment in Canada for a period of over 7 years (cumulative) at the competition deadline (e.g. faculty appointment that provides eligibility to apply for grants/supervise trainees).
- Has not previously <u>been a recipient</u> of the Senior Investigator Award.

CRTIERIA

- Productivity in research (e.g., publications, grants, service on grant review panels).
- Productivity in education (e.g., training of students who have followed a course of academic IM).
- Establishment of research opportunities for GIM in Canada through the creation of an academic environment for research on a local, regional or national basis.
- Impact or potential impact of research.
- Relevance to GIM in Canada.
- Supervisory duties, mentoring of junior colleagues, etc.

AWARD

The recipient must present a lecture relevant to the target audience (IM/GIM physicians) relating to their research area during the CSIM Annual Meeting, October 16-19, 2024 in Hamilton, ON. The recipient will receive:

- A certificate of recognition.
- Complimentary registration to the 2024 CSIM Annual Meeting.
- Reimbursement of economy-fare travel (from city of residence) to Hamilton.
- Hotel accommodation (up to two nights standard room & taxes at the host hotel) to participate in the 2024 CSIM Annual Meeting.
- A \$1,000 cash prize. Social Insurance Number required for tax purposes by the Canada Revenue Agency.

The recipient will be:

- Invited to judge an Annual Meeting event such as oral or poster presentations.
- Encouraged to submit their work to the <u>Canadian Journal of General Internal Medicine</u>.
- Announced via the CSIM's website, social media, e-newsletter, and/or the CJGIM.
- Invited to join the CSIM Research/QI Committee.

NOMINATION INSTRUCTIONS

- 1. The candidate's current curriculum vitae.
- 2. Two letters of support outlining the candidate's research accomplishments and the significance of the candidate's contributions to the field of general internal medicine. If a major part of the candidate's research has been done as a group, the candidate's role in the work should be specified.
- 3. A personal reflection from the nominee on the impact or potential impact and pertinence of their research to GIM and how their research portfolio fits within the subspecialty of GIM (up to 300 words).
- 4. Summary (up to two pages) highlighting up to five of the candidate's most important papers, especially those pertaining to the areas which define the GIM subspecialty (include reprints of any articles which are not open access).
