CALL FOR ABSTRACTS Research and Quality Improvement

The Canadian Society of Internal Medicine (CSIM) invites its Resident and Student Associates to submit abstracts to the Postgraduate Research and Quality Improvement (QI) Oral and Poster Competition held during the CSIM 2026 Annual Meeting.

SUBMITTER ELIGIBILITY

- This competition is open to residents enrolled in a postgraduate residency training program (PGY1 to PGY5) in Internal Medicine (IM) or General Internal Medicine (GIM) in Canada at the time of submission.
- The competition is also open to medical students (second year and higher) currently enrolled in a Faculty of Medicine in Canada at the time of submission.
- Applicants must be CSIM Resident or Medical Student Associates.

You MUST be a CSIM Resident or Student Associate to apply.

Residents and medical students join the CSIM for FREE!

Associate applications must be received at least one week prior to your abstract submission.
You will not be able to submit your abstract until your application is approved.

ABSTRACT SUBMISSION

1. Abstracts should present a clear, concise summary of the work and be up to 300 words in English (up to 350 words if submitted in French).
2. Projects must be IM- or GIM-related and be complete with results.
3. Organize the body of the abstract to include:
 - Background / Problem Statement
 - Objective / Aim
 - Methods / Intervention
 - Measures / Outcomes / Results
 - Conclusion / Impact and Lessons Learned
4. Only one abstract, across the Research, QI and Clinical competitions, may be submitted per person. A project may be submitted only once by any one of the project authors. All correspondence regarding the submission will be sent only to the submitter.
5. Abstracts authored by AI are not eligible for submission. Assistive AI tools may be used and do not need to be declared.
6. The abstract **must not** include city/province, hospital, co-authors, initials, references, introductions, historical data, literature reviews, bibliographies or financial support details.
7. Do not include images and graphs in the submission; however, they may be included (fully anonymized) in the presentation or poster if accepted for presentation.

8. Abstracts accepted in a previous CSIM abstract competition (oral or poster) are not eligible to be re-submitted.
9. Abstracts submitted to or presented at other national or international meetings are eligible for submission.
10. Abstracts are not eligible for submission if the work has been published as a full paper in a peer-reviewed journal prior to the submission deadline.

ABSTRACT REVIEW

- An independent review panel will review each blinded abstract for eligibility and content.
- The abstract will be reviewed as submitted. Abstracts cannot be edited or revised after submission. Grammar, spelling, etc. will not be checked or edited prior to review. Any identifying information (such as city, province, hospital, etc.) will be removed to blind your abstract. Sample judging criteria may include:
 - The abstract is clear, concise, and well-constructed.
 - The study is appropriate to the question.
 - Conclusions are well supported.
 - Relevance to GIM in Canada.
 - Impact Factor.
- Applicants will be notified of results by late summer.

SELECTED ABSTRACTS

- All co-authors of abstracts selected for presentation will be required to complete a [Conflict Disclosure form](#).
- Presentations must include a list outlining all the conflicts, or lack thereof, of all co-authors.
- The name, city and university of the submitter only will be included in the listing of posters, and/or the program and may also be acknowledged through the CSIM and ACP websites, e-newsletters, and/or social media. Co-authors may be acknowledged on the poster/slides.
- Only the submitter may present the abstract – co-presenters are not permitted.
- All presenters accepted for oral or poster presentation must register for the CSIM 2026 Annual Meeting at the posted rates.
- The top three winners in each category will receive a cash prize.
- Abstracts presented may be published in the [Canadian Journal of General Internal Medicine \(CJGIM\)](#); authors may opt out of publication. Authors may be contacted by the CJGIM about submitting the abstract as a full manuscript.
