

CALL FOR RESEARCH AND QUALITY IMPROVEMENT ABSTRACTS TERMS OF REFERENCE

The Canadian Society of Internal Medicine (CSIM) invites its Resident and Student Associates to submit abstracts to the **Postgraduate Research and Quality Improvement (QI) Oral and Poster Competition**.

ELIGIBILITY

- This competition is open to residents enrolled in a postgraduate residency training program (PGY1 to PGY5) in Internal Medicine (IM) or General Internal Medicine (GIM) in Canada at the time of submission.
- The competition is also open to medical students (second year and higher) currently enrolled in a faculty of medicine in Canada at the time of submission.
- Applicants must be CSIM Resident or Medical Student Associates.

If you are not currently a CSIM associate, you MUST complete an application to join the [CSIM](#). Residents and medical students join the CSIM for free!

Applications must be reviewed prior to approval; please apply at least 5 business days prior to the submission deadline. You will not be able to submit your abstract until your application is approved.

SUBMISSION INSTRUCTIONS

1.
 - Abstracts must be submitted in English and be no more than 350 words.
 - Abstracts must present a clear, concise summary of the work.
 - Abstract topics must be IM- or GIM-related.
 - QI abstracts must use QI methodology.

(Case reports are not accepted; refer to the [Clinical Abstracts Terms of Reference](#).)
2. Organize the body of the abstract to include:

(one sentence) • Aim: What is the aim of the project? • Improvement / Innovation: What changes were implemented? • Measures: What measures were or will be taken to determine if the project will lead to an improvement? • Project Impact: How do you expect the project to lead to an improvement? • Results and lessons learned (complete projects only.)

3. Incomplete projects with results expected to be available by Fall 2025 may be submitted but will be eligible for e-poster display (non-judged) only.
4. A project may be submitted only once by any one of the project authors. All correspondence regarding the submission will be sent only to the submitter.
5. Do not include city/province, hospital name, co-authors, initials, references, introductions, historical data, literature reviews, bibliographies or financial support details in the submission. Images and graphs may not be included in the abstract submission, but may be included (fully anonymized) in the presentation or poster.
6. Individuals may submit up to two abstracts across both CSIM abstract competitions (Research/QI and Clinical); however, only one oral may be presented and only one poster may be presented across both competitions.

7. Abstracts submitted to or presented at other national or international meetings are eligible for submission.
8. Abstracts are not eligible for submission if the work has been published as a full paper in a peer-reviewed journal prior to the submission deadline.

ABSTRACT REVIEW

- The abstract will be reviewed as submitted. Abstracts cannot be edited or revised after submission. Grammar, spelling, etc. will not be checked nor edited prior to review. Any identifying information (such as city, province, hospital, etc.) will be removed to blind your abstract.
- A review panel will evaluate each abstract for eligibility and content.
- Applicants will be notified of results by late summer.

SELECTED ABSTRACTS

1. All co-authors of selected abstracts will be required to complete a [Conflict Disclosure form](#).
2. Selected abstracts must include a list outlining all the conflicts, or lack thereof, of all co-authors (either on the poster or as a presentation slide.)
3. The name, city and university of only the submitter will be included in the listing of posters and/or the program and may also be acknowledged through the CSIM and ACP websites, e-newsletters, and/or social media. Co-authors may be acknowledged on the poster/slides.
4. Only the submitter may present the abstract (co-presenters are not permitted).
5. All presenters accepted for oral or poster presentation must register at the posted rates for the CSIM/ACP Atlantic Provinces Chapter Annual Meeting October 15-17, 2025 in Halifax, NS.
6. The top three winners in each category will receive a cash prize.
7. Abstracts presented will be published in the [Canadian Journal of General Internal Medicine \(CJGIM\)](#); authors may opt out of publication. Authors may be contacted by the CJGIM about submitting the abstract as a full manuscript.

DEADLINE: JUNE 4, 2025

At 4:00pm Eastern Time

The abstract submission system will close at the deadline.
